

Profile of Progress

Nineteen hundred sixty-five represents the most phenomenal growth period in Crossroads' 29 year history. (2,090 patients, 81,914 treatments, 150,904 hours of service, and 21, 290 patients transported.) The ever-growing and unprecedented confidence physicians and the public place in Crossroads is testimony to the great need the Center is filling in the rehabilitation of the handicapped. Enthusiastic support for Crossroads continues to grow because "at Crossroads you see where your money goes and more important, you see the good it does."

As a locally owned and administered community supported rehabilitation center, Crossroads will continue this phenomenal growth rate to better serve the community through Medical, Social, Psychological, Vocational, Educational, Research and Demonstration services. The twenty-nine year history of Crossroads' growth is an inspiring tribute to its lay leaders, the medical profession, its staff, and to the thousands whose personal interest has made it all possible. Crossroads is not only the largest outpatient comprehensive, community rehabilitation center . . . but the best! Crossroads renders a complete rehabilitation service for adults and children suffering from minor sprains to severe disability due to disease, congenital defects, or accidents. A team concept is the basis for all Crossroads' services with the Medical Director serving as co-ordinator.

Crossroads renders a complete and comprehensive rehabilitation service for mentally, emotionally, and physically handicapped adults and children. Patients are referred to the Center by their private physician. There are no geographical limitations for admission. Crossroads' patients come from throughout the nation



- PHYSICAL THERAPY. A staff of registered physical therapists give all Physical Therapy treatments at Crossroads. The latest methods and most modern equipment including diapulse, diathermy, whirlpool, paraffin bath, hydrocollator packs, Hubbard tank, and other devices are used. Crossroads is the best equipped rehabilitation center in the world.
- **2** OCCUPATIONAL THERAPY. All treatments are given by Registered Occupational Therapists. The patient's maximum physical restoration is accomplished through the use of graded activities for muscle strengthening and increasing range of motion.
- SPEECH THERAPY. All treatment is provided by graduate Speech Therapists, with Master's Degrees. Speech defects are treated that may include aphasia, delay of speech, articulation, dysartheria, stuttering, hypernasality, abnormal pitch, tongue thrust, vocal paralysis and laryngectomy.

Services







- DAY CAMP. One hundred handicapped children annually enjoy the camping activities of Camp Crossroads. Arts and crafts, nature study, swimming, games, and outdoor cooking are among the wonderful experiences shared by these children. A qualified Recreation Director supervises the camp with the assistance of fifty trained volunteer counselors.
- **2** VOLUNTEERS. Last year, 1,605 volunteers provided 180,000 hours of devoted service to Crossroads. These interested persons gave needed assistance in the Day Camp, Nursery, Developmental Program, Therapy departments and donated extensive service to the Easter Seal campaign and other special events.
- NURSING EDUCATION. More than 200 Registered Nurses from throughout Indiana participated in a program of instruction in Rehabilitation Nursing Techniques. Headed by a Registered Nurse, the course is being conducted through the cooperation of the Indiana State Board of Health.


Services



2 VOCATIONAL EVALUATION. Supervised by a registered Occupational Therapist, this department reviews work experience, evaluates physical capacities and manual skills, and selects suitable job objectives commensurate with physical limitations and aptitudes.



DRIVER'S TRAINING. Supervised by a qualified and experienced instructor, physically handicapped adults and teenagers have an opportunity to participate in the only driver's training course for the handicapped in Indiana. Driving lessons are given on a full powered, dual control automobile equipped with hand controls.



3 VOCATIONAL COUNSELING. A graduate Vocational Counselor discusses the patient's vocational problems, evaluates his physical capabilities and determines a suitable vocation. The counselor maintains contact with industrial personnel directors to arrange for interviews and job applications.

Staff

Crossroads enjoys a national reputation for high professional standards which have served as the criterion for other rehabilitation centers throughout the country. Crossroads' staff has given more than 1,081,-809 treatments to 21,486 patients, ranging from corporation presidents, to housewives, to children.


All therapists are graduates of colleges and universities approved by the American Medical Association and are registered members in good standing with their respective national organizations.

Crossroads provides transportation service for patients who are not ambulatory, maintaining a fleet of 8 station wagons. More than 8,238,227 accident free miles have been driven in picking up and returning patients to their homes.
